## National Leadership



The Arc of Frederick County's Executive Director, Joanna Pierson, served as President of The American Association on Intellectual and Developmental Disabilities.

## Statewide Advocacy

To address the Developmental Disabilities Waiting List Crises and Underfunding of Community Programs, The Arc of Frederick County and Working Together Frederick County Advocacy Group partnered with advocates from around Maryland to lead a Western Region Town Hall Meeting. Over 300 people attended the Town Hall Meeting and joined thousands of Maryland citizens in expressing their concerns for people with intellectual and developmental disabilities.



## Training



To support families, self-advocates, and professionals, The Arc of Frederick County hosted a series of trainings on Relationships and Sexuality. The training was provided by Leslie Walker-Hirsch, an internationally recognized educational consultant who specializes in social and sexual development for individuals with intellectual disabilities. She is a lecturer and co-creator of the widely used CIRCLES curriculum series. Leslie's support is allowing The Arc to build upon her training and offer ongoing Relationship Trainings to serve Frederick County.



## Expansion of Local Services

The Arc of Frederick County was one of 45 local chapters of The Arc across the United States to be awarded a sub-grant as part of the Walmart Foundation School-to-Community Transition Project to increase transition outcomes and build inclusion of youth with intellectual and developmental disabilities in employment and post-secondary educational opportunities. The Leadership, Enrichment, Achievement Program at Frederick Community College (LEAP at FCC) will be expanded and used as a model of success for other communities to duplicate. LEAP at FCC is a collaborative project between The Arc of Frederick County, Frederick Community College, and Frederick County Public Schools.



## Self Directed Supports

Building upon the model of self-directed supports created by The Arc of Frederick County in 1984, Support Coordinators from The Arc partner with individuals and their families to locate, purchase, and create the services they need in their communities. Person directed planning honors the value of individual preference and control over one's life in coordinating their residential, career, respite, and other community supports.

## Information and Referral

The Arc of Frederick County honors the commitment made by our founding members to serve as a resource for anyone who contacts The Arc and needs assistance with navigating the social services system, problem solving, educational advocacy, connections to support groups, and referrals to community resources. This much needed service allows The Arc to partner with families and the Frederick community to promote independent living, inclusive education, and employment opportunities.

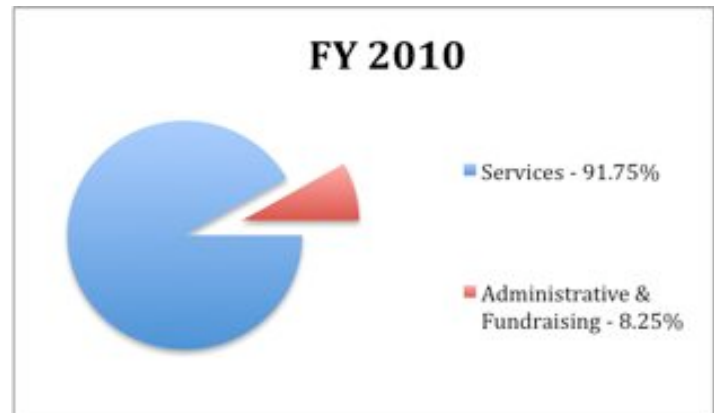
