- Frederick County offers several affordable housing programs for people who meet their requirements. The most popular are Section 8 Subsidized Housing, Public Housing, and Low Income Senior Housing.
- Section 8 subsidized housing can give rental assistance to people with limited income. If eligible, you can rent a house, townhouse, mobile home or apartment anywhere allowed by the housing agency. Waiting lists are long, so it is best to apply early.
- Public Housing was established to provide decent and safe rental housing for eligible low-income families, the elderly and individuals with disabilities.
- There are several Low Income Senior Apartments available throughout the county, with an additional age requirement. These apartments typically have added security, and a manager who is onsite.
- The Housing Authority of the City of Frederick participates in the city's Section 8 Housing Choice Voucher, Public Housing, Low Income Senior Housing and several other affordable housing programs. - Maryland Homeownership Program for Individuals with Disabilities is a home loan program through the Maryland Department of Housing. It is available to individuals with disabilities and their caregivers who meet the program's eligibility criteria.
