

Futures and Estate Spring Update

March and April have been full of activity for our Futures & Estate Planning project at The Arc. We began on March Ist with a general informational presentation for parents at Rock Creek School. Next we were very happy to offer our meeting space at The Arc at Market Street as a venue for a Maryland ABLE Program Listening Session presentation by the implementation team of the Maryland ABLE program.

Our next scheduled presentation, "The Letter of Intent", was cancelled due to the one and only snow storm in March! We did reschedule the presentation for April 4th, and began offering two time periods, a morning and an evening time, enabling more parents and caregivers to fit our presentations into their schedules. Additionally, we offered a presentation about Financial Planning to The Arc's Hispanic Outreach Group.

To close out March, we hosted a major seminar about Supported Decision-Making and Alternatives to Guardianship. We held this seminar at The Arc at Market Street, where we had attorneys and self-advocates offer presentations, parents of children with disabilities on a question and answer panel as well as a fantastic dinner buffet prepared by the catering program at The Arc. We hope this is the first of many presentations to promote Supported

Decision-Making as a workable alternative to guardianship petitions in Maryland. Following the rescheduled presentation on April 4th, we again offered two time slots for our "Financial Planning" presentation April 11th.

We will end our spring presentation series with our "Healthcare Decisions" discussion on Tuesday, May 9th. This session will be held in the conference room at The Arc at Market Street, from 11:00am-12:00pm, and then repeated at 6:30pm-7:30pm. Please come and join us for this informative session.

After a summer break, we intend to start our presentations again in the fall with a series of sessions about Financial Planning and Money Management.
